It was an honour to serve as President of Community Living Chatham-Kent (CLC-K) during the 2023-2024 year. Working with such a dedicated and talented Board of Directors was a pleasure.

Last June, Val Oriet exited the Board after making valuable contributions, and Gary Oriet was welcomed to the Board.

CLC-K was financially healthy during the 2023-2024 year.

The Board approved a Memorandum of Settlement between CLC-K and OPSEU Local-148.

The agency underwent a Quality Assurance Measures Compliance Review during the period of November 27th – December 8th. Jennifer Istl, from the Ministry of Children, Community and Social Services, completed site inspections at Baxter, Crerar, Stirling, Houston, and Southend, reviewed seventy-six (76) files of people who accessed services, fourteen (14) employee files, Board Records, Board Minutes, Serious Occurrence Reports, Fire Safety Plans, Monthly Health & Safety Inspections, Annual Inspection Reports, and Fire System/Evacuation checklists. CLC-K did well.

I congratulate David Muckle, Ella LaMarsh, and Charlie Beintema, winners of the Rob McLandress Make A Dream Come True Fund, Bruce Cockburn, recipient of the Joan Olive Risdon Memorial Award of Distinction, and NAPA Southam Automotive in Tilbury, winner of the Joyce M. Carr Champion Award.

Paul Mayrand, representing the Mayrand Family Fund, presented a cheque for \$2,584 to Steve Stokley, Manager, at the Chatham-Kent Community Foundation Annual General Meeting. The funds were allocated to the JOBWORX Summer Student Employment 2023 Program, providing secondary school students with opportunities to work at local businesses and enhance their skills for future careers.

The agency donated \$1,000 from the Food Truck Crawl to R.O.C.K. (Reach Out Chatham-Kent) in Chatham, and Wallaceburg. The locations in Chatham and Wallaceburg served over seven-hundred (700) lunches every week.

With respect to Equity, Diversity, and Inclusion, Indu Radhakrishnan provided training to agency personnel.

I thank the Board Members, employees, committee members, volunteers, and community partners for their ongoing commitment to this excellent agency.

I anticipate that the 2024-2025 year will be outstanding with the people accessing services remaining the top priority.

We worked in partnership with the Ministry of Children, Community and Social Services, Municipality of Chatham-Kent, St. Clair Catholic District School Board, Lambton Kent District School Board, St. Clair College, Community Living Ontario, Ontario Agencies Supporting Individuals with Special Needs, and businesses.

I offer my sincerest thanks to the Board of Directors for its wisdom and strong leadership, to Jodi Skipper, Lisa Blonde, Mickey Kovacs, Brad Verfaillie, and Angela Corso for their dedication, and to the best employees in Ontario.

The people who accessed services were, and always will be, the agency's number one priority. The Direct Support Professionals provided the finest supports, and their compassion, and commitment were excellent.

MPP Trevor Jones was very supportive of CLC-K. He golfed in the agency's Annual Golf Tournament, and because of MPP Jones I attended 'Coffee and Cannoli' with Minister David Piccini, Ministry of Labour, Immigration, Training and Skills Development.

Our Integrative Partnership with DeafBlind Ontario Services, and PHSS-Medical & Complex Care in Community continued.

The Family Network and CLC-K were very happy to host a Henson Trust and Registered Disability Savings Plan (RDSP) Seminar. The presenters were Brad Langford from Brad Langford Law Offices and Ken Bechard and Ian Bechard from Arrival Benefits Solutions. The seminar was outstanding.

CLC-K held a ceremony to mark the beginning of Truth and Reconciliation Week. Angel N. read a poem that spoke to the importance of reflecting, educating, and honouring those children who never returned home, as well as those who continued to be affected by the residential schools. Every Child Matters flags were flown at the Administration Building, 1099 Park Avenue, and 101 Stewart Street. In October, Minogiizhgad provided Indigenous Culture Competency Training to agency employees.

Community Living Chatham-Kent hosted its first ever Employee Wellness Fair at 1099 Park Avenue. There were more than one hundred (100) attendees, and several vendors were present. The Wellness Committee Members were Rochelle Stothart, Brad Verfaillie, Heather Robertson, Nicole Jubenville, Lee McFadden, Dava Grocott, Norma Hunt, Aaron Watson, and Megan McDermott. A very special thank-you, and congratulations to Janna Stawarz, Support Resources Manager, for an incredibly successful event.

The 25th Annual Golf Tournament held at Willow Ridge Golf and Country Club in Blenheim was a success, raising \$11,836.92. The Food Truck Crawl was held at Sons of Kent Brewing Company and the event generated \$13,910.85.

In closing, I offer my gratitude to the people, their families, and the employees, as Team CLC-K looks forward to the 2024-2025 year.

FINANCE COMMITTEE REPORT

Community Living Chatham-Kent had a productive 2023-24 operational performance.

There was an Increase in Fund Balances of \$799,894 (2023-23 \$1,301,136),

Increase in Cash & Marketable Securities of \$359,327, (2022-23 \$591,843)

Current Assets compared to Current Liabilities (Working Capital) increased \$508,649, Current Ratio 2.51 from prior year of 2.03.

We had a reduction in our Term/Mortgage Loans from \$602,878 to \$547,373, a decrease of \$55,505 in paid principle.

Community Living Chatham-Kent in 2023-24 continued to experience a strong financial performance and was in a salubrious Financial Position.

Community Living Chatham-Kent's Administration costs year over year had an increase of 4.6% (\$56,026) from the prior year. Administration costs as a percentage of Ministry Revenue were 6.90% (2023-24) versus 6.69% (2022-23) well within the 8% Ministry guidelines.

Excluding MCCSS programs and Capital Asset funding, Community Living Chatham-Kent exceeded their budget of \$142,441 by \$368,731 to \$511,172, via strong interest income of \$152,000 & Market performance of \$73,000, and Passport net revenues of \$119,000.

The Ontario Disability Support Program – Employment supports had a disappointing year with the transition to privatization from an Ontario funded program. Revenues decreased to \$224,000 from \$400,000 the prior year thus reducing its net income to \$23,000 while prior year reflected \$221,000.

During the fiscal year 2023-24 Community Living Chatham-Kent was active on the Capital front, completion of the Southend Crescent home (\$297,000), four vehicles purchased (\$190,000) and location improvements (\$213,000).

We should all feel proud, as well as assured that Community Living Chatham-Kent is looking at 2024-25 stronger, financially sound, and ready to meet the continuing challenges that may come our way. Let us continue to work together to bring the lives of the people we serve increased involvement. "All people live in a state of dignity share in all elements of living in the community and have the opportunity to participate effectively."





1.0 Welcome

Stephen Andari welcomed everyone to the 68th Annual General Meeting and opened the meeting at 6:31 p.m.

2.0 A land acknowledgement statement was presented by Ron Coristine to recognize and honor Indigenous Peoples as traditional stewards of the land.

3.0 Congratulatory Messages

Stephen Andari introduced Mayor Darrin Canniff.

Darrin spoke virtually and expressed his gratitude to the organization for the invitation to attend the Annual General Meeting and for all of the great contributions CLC-K makes within our community.

Stephen thanked Darrin and introduced Dr. Robert Walsh, President, OASIS.

Robert spoke about the work OASIS is involved in throughout the province and thanked the CLC-K staff for helping connect people who access service to the community. Robert expressed his gratitude to the agency and Board of Directors for their service and diligence throughout the years.

Stephen thanked Dr. Walsh and introduced Nadine Crumb, Program Supervisor from the Ministry of Children, Community and Social Services, who spoke virtually on behalf of the MCCSS.

Nadine commended the agency on the commitment and adaptability demonstrated as they work in new creative ways. Nadine acknowledged CLC-K as a leader in supporting people in Chatham-Kent and thanked the Board of Directors and staff that ensure the people in the community are supported.

Stephen thanked Nadine and shared greetings on behalf of MP Dave Epp, who was not able to be in attendance.

5.0 Review of Annual Report

Ron Coristine reviewed the Annual Report for 2022-2023.

Ron offered his sincere thanks to the Board of Directors for their support and leadership over the past year. Ron thanked Jodi Skipper, Lisa Blonde, Mickey Kovacs, Brad Verfaillie, Angela Corso and all of the staff for their dedication to the agency. Ron expressed his appreciated to Local-148 President Jennifer Ganley, and Past President Wayne Easterbrook.

Ron took the opportunity to commend the people and families who access services. They will continue to be the agencies number one priority.

Ron also extended thanks to Program Supervisor, Nadine Crumb for her support over the past year.

Ron reviewed the Annual Report and touched on the following:

Janna Stawarz and Rochelle Stothart provided Mental Health First Aid training to agency employees. The Wellness Committee, whose goal was to promote and ensure the physical and mental wellness of employees, had many resources available.

CLC-K has made a commitment to Equity, Diversity, and Inclusion training for agency personnel. The training will be facilitated by Indu Radhakrishnan.

Ron anticipates a bright future for Community Living Chatham-Kent and offered his gratitude to the people, their families, and the employees, as Team CLC-K looks forward to the 2023-2024 year.

6.0 Acceptance of Minutes of 2022 AGM

The financial statements are in compliance with Canadian accounting standards for not-for-profit organizations. In the opinion of KPMG the financial statements present fairly, in all material respects the financial position of Community Living Chatham-Kent as at March 31, 2023.

Leon Leclair (Doug Toland) moved that the Audited Financial Statements for the fiscal year 2022-2023 be accepted as presented.

Liz Zantingh (Jack Barei) moved that the firm of KPMG be reappointed as Auditors for Community Living Chatham-Kent for the fiscal year 2023-2024.

Doug has served on the Board for the past six years and has also volunteered his time as a member of the Building Committee as well as the Executive Committee, serving as Vice President. Doug has been a very dedicated and knowledgeable member of the Board, continuously supporting the agency at many events.

Ron thanked both Val and Doug for their dedication to the Board and presented them each with a gift.

9.0 Introduction of Candidates and Election of Board Members

Connie Marion announced the recommendations of the Nominating Committee. Connie presented the slate of officers to the membership. There are three people who have a one-year term remaining: Liz Zantingh, Kayla Murphy and Tony Carrington. There are four Board Members eligible for reelection; Leon Leclair, Connie Marion, Jack Barei and Stephen Andari. All have agreed to let their names stand for re-election. We also have three new proposed nominees for election to a two-year term; Gary Oriet, Clayton Willams and Zoli Horvath.

Connie then called three times for nominations from the floor. Hearing none she then asked for a motion to close the nominations.

Val Oriet (Doug Toland) moved that the nominations be closed and the recommendations of the Nominating Committee be accepted as presented.

Connie completed the installation ceremony with Clayton and declared him as a regularly installed Director of Community Living Chatham-Kent. (Gary and Zoli to be installed at the next Board Meeting in September).
